Sub:-Instructions to take photograph of Pillar And Power Plant

The Divisional Executive Committee meeting of SNEA Ernakulam SSA met on 09/07/2015 has decided to bring the following points for your consideration and necessary favourable decisions.

- 1) It is learned that as per the instructions from circle office for taking the photograph of Pillars and Power plants, SSA is proceeding with this assignment. While we are unable to understand the real purpose behind such a task the executives have very much limitation in executing this work. So far the photography work was not entrusted to the executives and this has to be got done through external agencies for which necessary arrangements may be made available in a uniform manner throughout the SSA like photographer and the expenditure since the rates may vary from place to place and agency to agency. Any how we take this opportunity to inform the SSA management that most of the pillars are in bad shape for want of timely rehabilitation work due to the shortage of material like CTB, Modules Jumper wire and labour assistance. It is requested to make arrangements for supply the required material and manpower if the real purpose is to improve the external plant. We have no hesitation to report that not even 20 % of the TMs are not capable to attend f cable fault and pillar wiring and no external suitable labour is locally available for the work. Hence there is urgent need for supply of material and suitable manpower for the pillar rehabilitation work which may be arranged by the SSA planning wing.
- 2) After implementation of ERP the bills for the contractors as well as the Vendors were not paying timely. As a result of this, the field units were not able to manage the petty contractors to the satisfaction of service.
- 3) Personal claims such as T/A, Medical reimbursement were not paying timely. The bill for reimbursement of Mobile Handset is bundled in section for more than six months.
- 4) The regularization of the leave pending cases was not settled so far, even though this was assured by your Good self that "it will be settled within one week" during the discussion with us on 26/6/2015.
- 5) The availability of healthy Batteries and Power Plant are to be ensured and also the timely repairing mechanism is to be arranged. The executives are forced to attend the Exchange failure even in odd hours due to the failure of Power Plant and the available Modules.

It is a request your good self may realize the actual situation in the field unit to maintain the day to day maintenance as well as the capital works, without getting the sufficient manpower and store. The executives are ready to do the task in the true spirit if the above facilities were provided
